### \*\*What Data Do We Collect?\*\*

\*\*Disclosure of Your Personal Information\*\*

Your personal information may be disclosed as follows:

- To third parties who provide services to AIN Medios, such as website hosting, data analysis, payment processing, order fulfillment, product distribution, infrastructure supply, IT services, customer service, email delivery, credit card processing if applicable, auditing services, and other similar services that enable them to provide services.
- To third parties, such as agents and distributors, to facilitate the sale and distribution of AIN Medios products and services, which may include marketing communications.

AIN Medios will disclose your information as deemed necessary or appropriate:

- (a) in accordance with applicable law;
- (b) to comply with legal processes;
